By signing this authorization form to restrict the use or disclosure of my medical information, I understand that:

- Restrictions to a health plan are only valid for items or services that have been <u>paid in full, out of pocket</u>. AdvantageCare Physicians will not submit a claim to the health plan for services that you have paid in full at the time the service was provided. I need to <u>notify the Patient Service Representative (PSR)</u> when presenting for the visit that I wish to restrict use or disclosure of my information to the health plan, pay for the service(s) in full ("Self-pay"), complete the information requested under "A" above and return it to the PSR at that time. I understand that AdvantageCare Physicians will grant requests for restrictions to health plans only if the service has been paid in full.
- Restrictions to individuals (family members or others) or other entities (excluding health plans) require completion of the form, as applicable. AdvantageCare Physicians will review the information to determine whether or not the request will be honored and notify me within 60 days from receipt of the request for restriction.
- I have the right to <u>revoke or modify</u> the restriction at any time. The request must be made in writing and presented to the applicable AdvantageCare Physician medical office or mailed to the Director of Health Information Management at the following address: 55 Water Street, 12th Floor Rm 12G09, New York, NY 10041.
- Restrictions will not apply to information that has already been used or disclosed as part of AdvantageCare Physicians'
 treatment, payment or operations or pursuant to previous authorizations from me to the individuals and/or entities
 identified at the time this form is completed.
- Unless otherwise revoked or modified, this restriction will expire on the following date/event/condition:
